

SKB SHUTTERS CORPORATION BERHAD (430362U)

Summary of key matters discussed at the Annual General Meeting (“AGM”) of the Company held on 2 December 2016 and published on the Company’s website pursuant to paragraph 9.21(2)(b) of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad.

At the Nineteenth AGM of SKB Shutters Corporation Berhad held on 2 December 2016, the shareholders and proxies present approved all the 15 Ordinary Resolutions tabled.

The matters discussed at the AGM are summarized as follows: -

1. The Chairperson extended a very warm welcome to all shareholders who attended the Nineteenth AGM and called the meeting to order and the Company Secretary confirmed that there was quorum present.
2. The notice convening the Meeting was taken as read. The Chairperson informed the shareholders that in accordance with the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, all the resolutions tabled will be voted by poll.
3. The Company Secretary brief the shareholders and proxies on the polling procedures. Agriteum Share Registration Services Sdn. Bhd. was appointed as Polling Administrator and IA Essential Sdn. Bhd. was appointed as scrutineers to scrutinize the poll process.
4. The Chairperson invited comments and questions from the floor on the Audited Financial Statements of the Company and the Group (“AFS”) for the financial year ended 30 June 2016 (“FY2016”) and the Reports of Directors. No question was raised.
5. The Chairperson proceeded to the Ordinary Resolutions 1 to 15 as set out in the notice of the Nineteenth AGM.
6. As the Ordinary Resolution 4 deals with the re-election of the Chairperson, she abstained from deliberation on the Ordinary Resolution 4 and passed the chair to Ms Sin Tze Yi.

Ms Sin Tze Yi chaired the meeting for Ordinary Resolution 4 on the re-election of Ms Sin Siew Huey, who retired in accordance with Article 125 of the Articles of Association of the Company and the Ordinary Resolution 4 was put to vote by way of poll. Ms Sin Tze Yi passed the chair back to the Chairperson to continue with the proceedings.

7. No matters were raised by the shareholders on all the resolutions.
8. The meeting was adjourned for about 15 minutes to facilitate the polling administrator and the scrutineer to tabulate and to scrutinize the poll results respectively.
9. The Chairperson announced the poll results for Ordinary Resolutions 1 to 15 as tabulated upon receipt of the verified report from the Scrutineer: -
